Testimony of Gregory W. Stype before the

Ohio Sunset Review Committee concerning the

State Council of Uniform State Laws

(August 28, 2024, 1:30 p.m. Session)

Chairman Wilken, Vice-Chairman Hillyer, and Members of the Committee –

Thank you for the opportunity to come before you this afternoon to briefly address the purpose of the Ohio State Council of Uniform State Laws.

As you are probably aware, the Ohio State Council of Uniform State Laws was created and exists under Section 105.21 et seq. of the Ohio Revised Code. The Ohio Council is comprised of four "commissioners" appointed by the Governor to three year overlapping terms. The Commissioners receive no compensation for their service but are reimbursed for their actual travel and other necessary expenses incurred in the discharge of their duties.

The purpose of the Ohio Council is to collect and digest information concerning state laws on subjects where uniformity among the states is important in our federal system. This includes, among other subjects, commercial law, corporations and partnerships, marriage and divorce, and trusts and estates.

Much of the Council's purpose is served through the participation of the Ohio Commissioners in meetings of the non-partisan National Conference on Commissioners of Uniform State Laws established in 1892. The States, District of Columbia and U.S. territories are members of and participate in the activities of the Conference. In addition to participating in the Conference's annual meeting, Ohio's Commissioners participate in various study and drafting committees of the Conference. The National Conference develops uniform and model acts—including revisions to the Uniform Commercial Code—for consideration by state legislatures. Its

drafting process is open to the public and includes input from experts, advisors and interested observers.

Attached is a list of more than 85 uniform acts that have been that have been adopted by the Ohio General Assembly.

I trust this gives you a helpful overview of the work and contributions of the Council and would be happy to address any questions.
